- If an error is made in the payment of your Direct Debit by the Lancashire Wildlife Trust or your bank or building society, you are entitled to a full and immediate refund of the amount paid from your branch of the amount paid.
If you receive a refund you are not entitled to, you must pay it back when the Lancashire Wildlife Trust asks you.
- You can cancel a Direct Debit at any time by contacting your bank or building society. Written confirmation may be required. Please also notify us.
